BRIEF INTRODUCTION

The **INTERNATIONAL NON-OLYMPIC COMMITTEE-INOC** has been formed on 25th March, 1997 by India with the intention to work as IOC's functioning: - the INOC is going to create **NATIONAL NON-OLYMPIC COMMITTEE-NNOC** in every countries of the World, where every NNOC will have to work with National Non-Olympic Sports Federations and the NNOC will have to organize National/International Events frequently as they can, and the INOC will organize World Events like; **NON-OLYMPIAD etc.**, it will be a MEGA Events, which will give reflection to the all Non-Olympic Sports at the global level as same as OLYMPIC Event.

The INOC is adamant to establish **Normalization, Integration, Social Unity, and World Peace** throughout the world by using the Sports as a tool.

The INOC is concentrating first to create **NATIONAL NON-OLYMPIC COMMITTEE-NNOCs** in all existing countries of the World as earliest as possible.

The **INOC** has been formed with sole-aims for developments, upliftments, recognition and popularizing the **Non-Olympic Games** and Country & Traditional Origin Games in all over the World as **Olympic Games**, which has been struggling to get its popularity amongst the peoples of the World and its due recognition from the "International Olympic Committee-**IOC**". In this regards, many countries of the World have also taken the idea seriously and developed **National Non-Olympic Committees (NNOCs)** with the practicable support and help of its pioneer i.e. **International Non-Olympic Committee-INOC**.

ABOUT NON-OLYMPIC SPORTS: - Presently the Non-Olympic Sports & Federations as well as players are struggling hard for their survival. The fact that they have no Super Body like as **IOC** from the date of the **IOC's** birth, the International Non-Olympic Sports Federations are working hard to give recognition & popularity to their sports.

The major portion of the International Non-Olympic Sports Federations is still waiting any miracle. In the light of the day, there is no scope for their players, and also they are not getting any financial help & assistance from the Governments as well as Private Sectors too, and the Electronics & Print Media are also not paying any attention to the Non-Olympic Sports and their Federations. Olympics Sports are getting wide publicity through the Electronics & Print Media, but for the Non-Olympic Sports yet to receive any kinds of these facilities.

The INOC has to create the following Continental Bodies:-

2. **EUROPEAN NON-OLYMPIC COMMITTEE**
3. **AMERICAN NON-OLYMPIC COMMITTEE**
4. **AFRICAN NON-OLYMPIC COMMITTEE**
5. **PACIFICEAN NON-OLYMPIC COMMITTEE**

The INOC would like to host a **Mini World Non-Olympiad** at the earliest; all the strategies will be decided in the coming Extraordinary Delegates Conference of the INOC. The purpose of hosting the **Mini World Non-Olympiad** is to highlight its effects and give a message to the World of Sports.

Expansion of its Executives Committee (INOC) and to elect all necessary committees & commissions etc. to look after all the activities of the INOC-Movement.

To decide the Venue, Date, Corporate Sponsors etc. and numbers of games that could participate in the proposed **Mini World Non-Olympiad**. Other major issues, related to the subject.

The IOC has been persistently harassing whosoever sport or country wishing to co-operate with the INOC movement duly and unduly by many means.

This action of the **International Olympic Committee (IOC)** has been considered detrimental to the advent of the **INOC (International Non-Olympic Committee)** and it **deterred its objectives to be attained.**
